To Whom It May Concern,

Thank you for supporting the Good Friday Appeal this year by providing collection permits for volunteers within your district. We greatly appreciate your time and guidance in the lead up to Good Friday. This year's result of **\$23,061,320** for the Royal Children's Hospital can be attributed to the generous involvement of organisations and communities throughout the state.

We are now currently underway in planning next year's Appeal. As I am sure you are aware, a change in legislation a few years ago requires all collection permit applications to be submitted to Victoria Police no later than 10 weeks prior to the event date. Therefore, we are seeking permits from Councils well in advance to ensure we can meet the Victoria Police deadline.

We understand that in the past, Greater Bendigo City Council have had no objection to intersection collections or door knock collections - as they are on private property - and as such, you do not provide a permit. However we require official documentation from all Councils in order to complete the application for Victoria Police so we are requesting an email from yourselves either, with approval of our activities as listed below, or stating that you have no objection to our activities as listed below and that we do not need a permit to conduct these activities.

So that the Appeal can apply for a state-wide Police Permit, I would be grateful if you could include all locations and details listed below in your correspondence and return to me by **Friday November 03, 2023**.
