1. Each area is only to be visited once.
2. Only one doorknock collection will be permitted in an area at any one time.
3. Public safety is not compromised by the operation of the activity.
4. Persons collecting must be over 18 years of age.
5. Collectors must wear a badge which is easily read by the public indicating whether they are paid workers or unpaid volunteers and show the name of the registered charitable organisation they are collecting for.
6. The permit holder may not approach individuals requesting money or solicit funds in a way that is overtly offensive to members of the public.
7. Highway collections can only be conducted at intersections where neither intersecting road is above 60kms.
8. The continued holding of public liability insurance policy for a minimum amount of \$10,000,000.

- The permit is subject to review at any time and may be varied or revoked if complaints or breaches are detected.
 - If circumstances change Council must be notified in writing immediately.
 - Permit holder/s at the request of an Authorised Officer of Council or Victoria Police Officer must cease any activities relating to the permit immediately or relocate to a different site on request.
 - Permit holders must comply with any current or subsequent Guidelines issued by Council.

To Whom It May Concern,

Thank you for supporting the Good Friday Appeal this year by providing collection permits for volunteers within your district. We greatly appreciate your time and guidance in the lead up to Good Friday. This year's result of **\$23,061,320** for the Royal Children's Hospital can be attributed to the generous involvement of organisations and communities throughout the state.

We are now currently underway in planning next year's Appeal. As I am sure you are aware, a change in legislation a few years ago requires all collection permit applications to be submitted to Victoria Police no later than 10 weeks prior to the event date. Therefore, we are seeking permits from Councils well in advance to ensure we can meet the Victoria Police deadline.

We understand that some councils don't process permit applications earlier than two months prior to the event date, but given the time restraints placed on us by Victoria Police we are asking that you make an exception and process our application as soon as possible.

We are also aware that some councils have no objection to intersection collections or door knocks and as such, do not provide a permit. However we require official documentation from all councils in order to complete the application for Victoria Police so we are requesting formal written approval from you.

So that the Appeal can apply for a state-wide Police Permit, I would be grateful if you could include all locations and details listed below in your correspondence and return to me by **Friday November 03, 2023**.
