To Whom It May Concern,

Thank you for supporting the Good Friday Appeal this year by providing collection permits for volunteers within your district. We greatly appreciate your time and guidance in the lead up to Good Friday. This year's result of **\$23,061,320** for the Royal Children's Hospital can be attributed to the generous involvement of organisations and communities throughout the state.

We are now currently underway in planning next year's Appeal. As I am sure you are aware, a change in legislation a few years ago requires all collection permit applications to be submitted to Victoria Police no later than 10 weeks prior to the event date. Therefore, we are seeking permits from Councils well in advance to ensure we can meet the Victoria Police deadline.

We understand that some councils don't process permit applications earlier than two months prior to the event date, but given the time restraints placed on us by Victoria Police we are asking that you make an exception and process our application as soon as possible.

We are also aware that some councils have no objection to intersection collections or door knocks and as such, do not provide a permit. However we require official documentation from all councils in order to complete the application for Victoria Police so we are requesting formal written approval from you.

So that the Appeal can apply for a state-wide Police Permit, I would be grateful if you could include all locations listed below in your correspondence and return to me by **Friday November 03, 2023**.

Door knock Collections:

Dates: Saturday, March 16 to Good Friday, March 29, 2024

Time: 9am - 5pm

Locations: Entire municipality

Intersection Collections:

Dates: Wednesday, March 27, Thursday, March 28 and Good Friday, March 29, 2024

Time: Sunrise to Sunset
